

Health Advisory Issued for Tenmile Lakes

The Oregon Health Authority issued a health advisory today due to high levels of blue-green algae in Tenmile Lakes, located eight miles south of Reedsport off U.S. Highway 101 in Coos County. Water monitoring has confirmed the presence of high levels of cyanotoxins produced by blue-green algae. These dangerous toxin concentrations in the water can be harmful to humans and animals. Swallowing or inhaling water droplets, as well as skin contact with water, should be avoided. Drinking water directly from Tenmile Lakes is especially dangerous. Exposure to toxins can produce symptoms of numbness, tingling and dizziness that can lead to difficulty breathing or heart problems, and require immediate medical attention. Symptoms of skin irritation, weakness, diarrhea, nausea, cramps and fainting should also receive medical attention if they persist or worsen. Children and pets are at increased risk for exposure because of their size and level of activity. The public will be advised when the concern no longer exists. Oregon Public Health officials advise campers and other recreational visitors that toxins cannot be removed by boiling, filtering or treating the water with camping-style filters. People who draw in-home water directly from Tenmile Lakes are advised to use an alternative water source because private treatment systems are not proven effective at removing algae toxins. However, public drinking water systems can reduce algae toxins through proper filtration and disinfection. If people on public water systems have questions about treatment and testing, they should contact their water supplier. Oregon health officials recommend that people who choose to eat fish from waters where algae blooms are present remove all fat, skin and organs before cooking, because toxins are more likely to collect in these tissues. Public health officials also advise that people not eat freshwater clams or mussels from affected water, and that Oregon Department of Fish and Wildlife regulations do not allow the harvest of these shellfish from freshwater sources. Crayfish muscle can be eaten, but internal organs and liquid fat should be discarded. With proper precautions to avoid water contact, people are encouraged to visit Tenmile Lakes and enjoy activities such as camping, hiking, biking, picnicking, fishing and bird watching. Boating is safe as long as speeds do not create excessive water spray, which could lead to inhalation risk. Scottsburg Bridge Accident

Highway 38 at the Scottsburg Bridge near milepost 16 was closed most of Thursday, Sept. 18, following a traffic crash involving a commercial truck pulling a flatbed trailer loaded with lumber products. The truck and trailer was hanging over the bridge railing above the river and an estimated hundred gallons of diesel had leaked into the river. According to Lieutenant Steve Mitchell, preliminary information indicates at approximately 8:20 a.m., a 1994 Peterbilt truck pulling a flatbed semi-trailer loaded with lumber products driven by a 54-year old male was eastbound on Highway 38 near milepost 16. For an unconfirmed reason, as the truck was negotiating a left curve it struck the guardrail and went onto the bridge railing. The lumber products spilled off the trailer as it went over the railing. The truck and trailer were partially hanging off the bridge over the Umpqua River. The truck's driver was taken by ambulance to Lower Umpqua Hospital with minor injuries. Oregon State Police (OSP), Douglas County Sheriff's Office, ODOT, Scottsburg Fire Department, US Coast Guard and local emergency responders were working together at the scene. Oregon Emergency Response System (OERS) was notified and a HazMat team had been contacted to respond and handle the diesel spill. One lane of traffic was reopened by 3 p.m. ODOT dispatched a bridge inspector to the scene to check for damage. The highway was reopened to traffic in both lanes just before 8 p.m.

Recent Rainfall Lowers Fire Levels

Weather changes have brought cooler conditions to the Coos Forest Protective Association. The reduced fire danger levels are allowing fire mangers to lower fire levels within the district. Lands protected by CFPA within Regulated Use Areas CS-1, CS-2, CS-4, CS-5, SK-1 and SK-2 will lower to a Level II (2). Changes are effective as of 8 a.m. today, Thursday, Sep-tember 18, 2014. IFPL II, or "partial hootowl", prohibits blasting, welding and cable yarding from 1:00 p.m. to 8:00 p.m. The use of power saws is also prohibited between these hours, except at loading sites. A firewatch of three hours is also required. The Regulated Use Closure will remain in place at this time. Power saw use is prohibited between 1:00 p.m. and 8:00 p.m. When permitted, each saw must have one axe, one shovel and one operational fire extinguisher that is of at least 8 ounce capacity. In addition, a fire watch is required for at least one hour following the use of each saw. Hunters and recreationists will need to contact local landowners to see if entry onto their land is permitted. For further information on fire danger levels and closures, contact

Great ocean coho season draws to a close

Great fishing and good weather throughout September means that quotas for ocean coho should be met in the next few days. As a result, the area from Cape Falcon, Ore. south to Humbug Mountain will close for coho salmon effective midnight on Friday, Sept. 19. The area from Leadbetter Point, Wash. to Cape Falcon, Ore. will close for all salmon at midnight on Sunday, Sept. 21. "This has been the absolute best September we've ever had for ocean coho fishing," according to Eric Schindler, ODFW ocean salmon project leader. "There were more fish in the quota than we thought we'd ever catch in September, but fishing has just been phenomenal." "The good news is that anglers can continue to fish for Chinook between Cape Falcon and Humbug Mt. through the end of October," Schindler added. Coastal streams and the Columbia River also remain open for coho. According to Chris Kern, ODFW administrator for marine and Columbia River programs, the final total will be over 100,000 angler trips for the 2014 ocean salmon season, the highest in 10 years. The total number of coho caught since June – which will exceed 83,000 – is the most since 2003. Overall, the 2014 ocean salmon seasons yielded almost one salmon per angler per trip for the entire season, which is much higher than average. "The September coho fishery has been very popular and productive thanks to good coastal coho returns," Kern said. "We can't always count on these kinds of returns, but this year is a great example of the kind of opportunity these fish can provide under good conditions." The 2014 fishery also demonstrated how important these fisheries are to coastal communities and the Oregon public, Kern added. While the ocean coho season is ending, coho fishing continues to be outstanding at Buoy 10 near the mouth of the Columbia River, where the crowds have largely gone home, the bag limit is up to three hatchery coho, and anglers have averaged more than two kept coho per person so far this week. Coho fishing, including the retention of wild coho where allowed, is also starting to pick up in coastal rivers and streams, and coastal Chinook fishing is expected to be very good as well.

Coos Bay Male in Hwy. 126W Accident

Oregon State Police (OSP) is continuing the investigation into an unreported serious injury crash found Tuesday morning by an ODOT employee and OSP trooper off the side of Highway 126W about ten miles west of Veneta. On September 16, 2014 at approximately 7:30 a.m., an OSP trooper patrolling westbound on Highway 126W was following an ODOT employee in a truck near milepost 38. The ODOT employee radioed to the trooper about possibly seeing a tire through the roadside brush. After the trooper and ODOT employee turned around and stopped on the side of the highway, they got out and confirmed there was an overturned vehicle off the highway and it was occupied by a seriously injured man. After calling for medical response, they started emergency medical care until relieved by personnel from Lane Fire Authority and an ambulance. LifeFlight responded to the scene and transported MICHAEL P. VINCENT, age 36, from Coos Bay, to Sacred Heart Medical Center at RiverBend where he is in the intensive care unit. His injuries do not appear to be life-threatening. Initial investigation indicates the crash happened overnight at an unknown time as the 2001 Chevrolet Impala traveled westbound, went off the highway and rolled several times.

interested in understanding native fish," says Shaun Clements, NFIP program leader. "Crowd-sourced funding is a way to get involved." Clements posted his current project, a survey of the Millicoma dace, to a fundraising website. People interested in donating to the project can go directly to the web site. The project is expected to cost about \$8,000, and Clements is trying to raise about a quarter of that through community funding. Millicoma dace are tiny forage fish found only in the Coos and Millicoma rivers. According to Clements, it's been almost 20 years since anyone has checked in on this Oregon native. "There is a concern for its well-being, so we're hoping to find a healthy population," Clements said. Millicoma dace currently are classified as a "strategy species" in the Oregon Conservation Strategy. Strategy species are defined as species with low and/or declining populations or otherwise at risk. Charleston District Fish Biologist Mike Gray ranked the dace as the fish species of highest concern in his district. "These fish have only been found in certain areas of the Coos basin. Even if they are healthy in numbers, it takes a dedicated effort to find them," Gray said. "They may be doing reasonably well, but we just don't know."

Hwy. 126W Fatal

Oregon State Police (OSP) is continuing the investigation into Tuesday evening's single vehicle fatal traffic crash that occurred along Highway 126W west of Veneta. OSP worked with the Lane County Medical Examiner and confirmed the victim is identified as LANCE MATTHEW HOSE, age 49, from Eugene. According to Master Sergeant Lang Hinkle, on September 16, 2014 at approximately 6:00 p.m., a 1995 Honda Accord station wagon containing one person was traveling eastbound on Highway 126W near milepost 36 negotiating a left curve when it went off the side of the highway and struck a tree. The vehicle caught fire and a passing motorist stopped at the scene. Due to the spreading fire, they weren't able to get the victim out of the vehicle or put the fire out as it spread to several trees and surrounding brush. Firefighters from Lane Fire Authority and Lane Rural Fire Rescue responded to the scene to extinguish the fire that spread to an estimated 3/4 of an acre area. The cause of the crash is unknown. The highway was blocked about two hours before one lane was opened to traffic. ODOT assisted at the scene with traffic control.

Coastal News

Curry Voters Say "No" again

With a 49-percent voter turnout for Tuesday's special election in Curry Co. to keep the county's jail open, failed 57-percent to 43-percent. Registered voters rejected an increase in their property tax rate to raise \$1.6 million to keep the jail in Gold Beach operational for three years. Sheriff John Bishop, who has already announced he is leaving the office this year for a new job, says the jail and its staffing are in jeopardy. The county is augmenting the jail's budget with money from the County Road Fund. That, however, will run out in 2016. Last November, Curry Co. voters rejected a \$3.2 million public safety tax increase that would have tripled property taxes.

Wave Energy Device Deployed

On Thursday, Sept. 18, two former Oregon State University students will retrieve a wave energy device from the Pacific Ocean seafloor off the North Oregon Coast to see how much electricity their APEX model generated in a two-week test deployment. Unlike other proposed wave energy devices, M3 Wave's is not a buoy that is tethered to the ocean floor and bobs in waves on the surface to generate electricity. Instead, it is anchored on the seafloor and generates electricity by inflating and deflating bags that is shot through a six-inch diameter pipe, spinning a turbine inside which creates electricity. Company CEO Mike Morrow and co-founder Mike Delos-Reyes attended OSU in the early 1990s. They built their first model out of milk bags and spoons from Dairy Queen. On Sept. 4th, the two, along with a crew, deployed the APEX off of Camp Rilea, near Warrenton in 50-feet of water. The APEX is rectangular-shaped, 30-feet long and 8-feet wide. The model is about one-fifth the size of a regular unit and with a bail of \$80,000.00.

Lincoln County Health and Human Services Clears Restaurant as Source of E.coli Infection

Rebecca C. Austen, Lincoln County Public Health Division Director, announced Wednesday, Sept. 17, that laboratory test results indicate

an Otis restaurant is not the source of infection in its ongoing E.coli investigation. Austen also stated that there have been no new reported cases of E.coli infection in Lincoln County since the start of the investigation. The Lincoln County Health and Human Services Department's Public Health Division conducted a thorough investigation of the restaurant and submitted samples taken as part of the investigation to the Oregon State Public Health Laboratory for analysis. "All of the test results have come back negative and our comprehensive investigation of the establishment did not reveal a link to the reported case," said Amy Chapman, Lincoln County Environmental Health Program Manager. Based on the current investigation results, public health officials are confident that there is extremely low risk of E.coli infection to the public. Officials stress that the investigation into the source of the infection is ongoing. They continue to urge everyone to take routine preventive measures against E.coli such as frequent hand washing, thoroughly disinfecting all household surfaces including bathrooms, kitchens and play areas, avoiding cross contamination during food preparation, washing fresh fruits and vegetables before eating and thoroughly cooking raw meat.

New Coastal Park Land in Oregon

The Oregon Parks and Recreation Department (OPRD) closed a \$1.8 million deal Friday, Sept. 13, to acquire 357 acres of coastal prop-

erty in Tillamook County. Known locally as the Beltz property, the ecologically diverse plot sits along Sand Lake Road north of Pacific City and south of Cape Lookout State Park. The acquisition is the first step in opening a new park, a process that could take a year or longer. The property consists of woodlands, dunes, oceanfront and both fresh- and saltwater marshes. OPRD purchased the land from Oregon-based nonprofit Ecotrust, which acquired it from a private landowner in May 2014. The final purchase price of \$1.8 million was determined by an appraisal and is funded by Oregon Lottery dollars dedicated to state parks. "We're bringing a new natural, outdoor experience to Oregonians thanks to two key partners," said Lisa Van Laanen, Oregon Parks and Recreation Department director. "First, Ecotrust put us in a position to purchase the property. Second, Oregon's citizens chose long ago to preserve the coast as a public place to explore and play, and they've given us the modest means to make

prudent investments such as Beltz to improve the experience." The department will work with the county and nearby residents to eventually open the park for hiking and bird watching, though a date has not yet been set. Plans include using existing low-impact trails and determining a safe public parking area, as well as preserving important habitat for coho salmon, great blue heron, bald eagles, songbirds and other wildlife. Oregon state parks in Tillamook County currently attract 1.7 million visitors, resulting in \$15 million a year in local spending, and a projected \$100,000 in lodging taxes from state park camping in 2014.

Fred Wahl Marine Expanding

Fred Wahl Marine of Reedsport has entered an agreement to purchase over 30-acres of industrial property abandoned by American Bridge on Bolon Island. The purchase will create 30 new full-time jobs with Fred Wahl Marine which currently employs about 80. American Bridge, based in Pennsylvania, cited a declining economy for the closure of two manufacturing facilities, including Reedsport earlier this year.

Central Coast Fake ID update

On September 16, 2014, at approximately 8:00 AM, Lincoln County Sheriff's Detectives received information from the Oregon State Police Identification Services Section that the fingerprints submitted belonging to "Stanhope, Quentin" were those of: Beaudoin, Gerard Marcel Joseph II, 60 years of age. Detectives were then notified that Beaudoin had two outstanding felony warrants, both for Forgery, issued in 2004. The warrants were from Jefferson Parish, Louisiana and New Orleans, Louisiana. Beaudoin was subsequently charged while at the Lincoln County Jail with two counts of Fugitive. 



As part of the commemoration for this day, one of largest POW-MIA flags in the United States will be raised onto the giant flag pole located at the Latus Harley Davidson dealership in Gladstone, Ore. At 11 a.m. Thursday, September 18, veterans groups will hoist the 50-by-70 foot flag into place and then lower it on Saturday. The dealership is located off of Interstate 205, exit 11 at 870 E. Berkeley St.



This past weekend, anglers at Buoy 10 averaged 6.2 coho per boat.
