Regional

I-5 Fatal, Marion Co.

On November 10, 2021, at approximately 7:38 P.M., Oregon State Police and emergency personnel responded to a motor vehicle collision involving a bicyclist on Interstate-5 northbound at exit 260 near Salem. A preliminary investigation revealed that a bicyclist identified as Anthony Lee Garza (61) was riding his bicycle across the northbound lanes of Interstate-5 when he was struck by a pickup truck operated by Benjamin J Miller (35) of Gervais. Miller remained at the scene and is cooperating with law enforcement. Garza was pronounced deceased at the scene.

Multi-Vehicle Crash, Hwy. 97, Deschutes Co.

On November 10, 2021, at 4:51 P.M., OSP responded to a multi-vehicle crash on Highway 97 milepost 114 near Terrebonne. A silver Hyundai Elantra, driven by Karl Thompson (58) of Metolius, was southbound on Highway 97 when it attempted to pass a southbound black Dodge Ram on the shoulder. The Dodge Ram was driven by Kyle Jensen (32) of Redmond. When the Elantra reentered the southbound lane, it struck the front of the Dodge Ram, sending the Elantra into the northbound lane. The Elantra then struck a Nissan Pathfinder, driven by Jessica Shaw (33) of Metolius. The Pathfinder was pushed into the southbound lane when it was struck by a Dodge Tow Truck, driven by Austin Ontjes (26) of Terrebonne. The driver of the Pathfinder, Jessica Shaw, was pronounced deceased at the scene. The passenger in the Elantra, Emmanuel Pina-Lopez (29) of Madras, was transported to an area hospital with serious injuries. The Driver of the Tow Truck, Aus-

tin Ontjes reported minor injuries. Karl Thompson, Kyle Jensen, his passengers along with the passenger of the Tow Truck did not report any injuries. The highway was closed for 6 hours. OSP was assisted at the scene by Deschutes County Sheriff's Office, Redmond Fire, Redmond Police Department, and the Oregon Department of Transportation. The investigation is ongoing.

I-5 Fatal, Marion Co.

On November 12, 2021, at approximately 9:18 P.M., Oregon State Police and emergency personnel responded to a motor vehicle collision involving a pedestrian on Interstate-5 southbound near milepost 254 in Salem. Preliminary investigation revealed a female pedestrian, who was identified as Christina June Klug (26) of Lebanon, exited her boyfriend's vehicle that was parked in the median on Interstate-5 southbound near milepost 254, walked out into the lane of travel, and was struck by a southbound vehicle operated by Maria Guzman-Coria (24) of Salem. Klug was pronounced deceased at the scene. Guzman-Coria remained at the scene and is cooperating with law enforcement.

OSP was assisted by Salem Fire and Medics and the Oregon Department of Transportation.

Hwy. 99E Fatal, Clackamas Co.

On November 13, 2021, at about 7:46 P.M., Oregon State Police Troopers and emergency personnel responded to the report of a multiple-vehicle fatal crash on Highway 99E in Oregon City. Preliminary investigation revealed a Kawasaki motorcycle, operated by Daniel Lucero (33) of Gervais, was headed southbound on SR-99E near Dunes Rd when, according to witnesses, he ran a red light and collided nearly head-on with a Chevrolet Van, operated by Joel Gibson (39) of Medford. As a result of the collision, Lucero suffered fatal inju-

ries and was pronounced deceased at the scene. The highway was closed for over three hours while the Oregon State Police investigated the incident. OSP was assisted by the Clackamas County Sheriff's Office, Oregon City Police Department, Gladstone Police Department, AMR, Clackamas Fire, Clackamas County ME's Office, and the Oregon Department of Transportation.

Vehicle vs. Pedestrian Fatal, Linn Co.

On November 13, 2021, at about 7:09 P.M., Oregon State Police Troopers and emergency personnel responded to a report of a pedestrian vs. Semi crash that occurred on Interstate-5 near milepost 234 southbound outside Albany.

The preliminary investigation revealed Daniel Montoya (39) of Albany was observed laying down on the northbound side of Interstate-5 and then began running across the northbound and southbound lanes of Interstate-5. As he crossed the southbound lanes of travel, he ran in front of a non-involved passenger car that swerved to not hit him. Behind, the passenger vehicle was a 2021 Mack semi-Truck driven by Alan Steven (26) of British Columbia, Canada, who was southbound in the slow lane of Interstate-5 and could not avoid colliding head-on with Montoya.

Montoya was pronounced deceased at the scene. OSP was assisted at the scene by the Albany Fire Department and the Oregon Department of Transportation. The southbound lanes of Interstate 5 were closed during this investigation.

Log brands discourage log theft

Log brands – the identifying symbols welded onto the face of a hammer and struck into the ends of logs for identification – discourage log theft and aid in the return of lost logs. When transported on public highways, waterways, or rail-

roads west of the crest of Oregon's Cascade Mountain range, forest products and booming equipment must have a log brand that has been registered with ODF. Under Oregon law, log brand registrations must be renewed every five years. Renewal forms will automatically be mailed to registered log brand owners on Oct. 18, 2021. Timber operators whose addresses have changed since their initial registration or last renewal need to provide ODF with their current address before Oct. 18 to ensure they receive their renewal certificate. Address information can be sent to the ODF's Log Brands Unit by phone or email: Phone: 503-945-7259; Email: Log.Brands@oregon.gov Operators who registered in 2021 must still renew their brands for the new five-year period (Jan. 1, 2022 – Dec. 31, 2026). The new log brands will be active through Dec. 31, 2026. Any log brands not renewed by Dec. 31, 2021 will be considered abandoned and the registration number will expire.

On Friday, October 1, 2021 at approximately 4:07 PM, Oregon State Troopers

and emergency personnel responded to a motor vehicle crash involving two motorcycles on Hwy 7 near milepost 34. Preliminary investigation revealed a Honda VTX1800, operated by David Anderson IV (35) of Gig Harbor, Washington and an Indian Roadster, operated by David Anderson III (65) of Gig Harbor, Washington were northbound and both failed to negotiate a curve and left the roadway. Witnesses confirmed the motorcycles did not strike each other. Anderson IV sustained fatal injuries and was pronounced deceased. Anderson III was transported via Life Flight to the hospital.

Hwy. 20 Fatal, Malheur Co.

On Saturday, October 2, 2021 at approximately 3:17 AM, Oregon State Police Troopers and emergency personnel responded to a single vehicle crash on Hwy 20 near milepost 252. Preliminary investigation revealed Hyundai Sonata, operated by Scott Barr Jr. (33) of Houston, Texas, was westbound when left the roadway, rolled and struck a tree. Barr sustained fatal injuries and was pronounced deceased.

Officer Involved Shooting Clackamas Co.

On October 4, 2021, at approximately 10:21 a.m., Molalla Police Department officers responded to a medical assistance call at the residence of Brian Mills, located on the 700 Block of W. Main St. Molalla, OR. After arriving on scene officers contacted Mr. Mills, who began arming himself. Officer's attempts to negotiate and de-escalate Mr. Mills were

unsuccessful. Mr. Mills began shooting at civilians and officers. A civilian received minor injuries as a result of gunfire and was treated and released from the hospital on October 4, 2021. Officers were able to evacuate all occupants from the area and no additional injuries were reported. One Molalla Police officer returned fire during the incident. Mr. Mills was eventually taken into custody without further incident. Mr. Mills was lodged at Clackamas County Jail on charges of Attempted Aggravated Murder, Attempted Assault first degree, Unlawful Use of a Weapon, and Recklessly Endangering. The Molalla Police officer was placed on administrative leave pursuant to Clackamas County Senate Bill 111 Protocols. No officers were injured in this incident and the officer's identity will be released at a later date.

Hwy. 51 Fatal, Polk Co.

On October 5, 2021 at approximately 7:36 PM, Oregon State Police Troopers and emergency personnel responded to a motor vehicle collision involving a bicyclist on Hwy 51 near milepost 4. Preliminary investigation revealed that a southbound bicyclist, Frank Koch (80) of Independence, was struck from behind by a southbound Toyota Prius, operated by Krystal Kamback, (33) of Independence. Koch sustained fatal injuries and was pronounced deceased. Kamback was uninjured, remained at the scene and is cooperating with law enforcement. Hwy 51 was closed for approximately 3 hours.

Hwy. 140E Fatal, Lake Co.

On Thursday, October 7th, 2021, the

Oregon State Police and Lake County Sheriff's Office responded to the report of a disabled vehicle near on Highway 140E near milepost 10. Upon arrival, it was determined that the vehicle was involved in a rollover crash. Preliminary investigation revealed an eastbound Ford Taurus, operated by Joshua Harrer (27) of Orovada, Nevada, for unknown reasons went off the roadway and rolled. Harrer sustained fatal injuries and was pronounced deceased.

Hwy. 199 Fatal, Josephine Co.

On October 14, 2021 at about 12:55 AM, Oregon State Police Troopers and emergency personnel responded to the report of a single vehicle crash on Highway 199 at mile post 15. Preliminary investigation revealed that a southbound Toyota Tundra crossed the northbound lane of travel and exited the roadway at a high rate of speed. The Toyota went up an embankment and rolled at least once before coming to rest on its top. The Toyota ignited and burned completely. The unidentified driver suffered fatal injuries and was pronounced deceased. Highway 199 was closed for approximately 3 hours.

Hwy. 26 Fatal, Grant Co.

On Thursday, October 14, 2021 at approximately 7:55 AM, Oregon State

Police Troopers and emergency personnel responded to a single vehicle crash on Highway 26 near milepost 152. Preliminary investigation revealed an eastbound Toyota Prius, operated by Janet Nevels (73) of Garden Valley, Idaho, drifted off the roadway, lost control and struck a concrete bridge structure. Nevels sustained fatal injuries and was pronounced deceased. Hwy 26 was closed from approximately 1 hour.

Hwy. 99E Fatal, Clackamas Co.

On Saturday, October 16, 2021 at approximately 6:49 PM, Oregon State Police Troopers and emergency personnel responded to a three-vehicle crash on Hwy 99E at Oak Grove Boulevard. Preliminary investigation revealed a northbound Chevy Trailblazer, operated by Angelina Sloan (43) of Portland, rear-ended a Toyota Yaris, operated by Terry Tomaszewski (59) of Milwaukie, that was stopped at a red light. The collision caused both vehicles to slide into the intersection where the Chevy Trailblazer also collided with a westbound Saturn SUV, operated by a 17-year-old female of Milwaukie, that was proceeding through the intersection on a green light. A passenger in the Toyota Yaris, Mary Ring (70) of Portland, sustained fatal injuries and was pronounced de-

I-84 Fatal, Baker Co.

On September 23, 2021 at approximately 2:14 AM, Oregon State Police Troopers and emergency personnel responded to a Commercial Motor Vehicle crash on Interstate 84 near milepost 318. Preliminary investigation revealed a Freightliner CMV pulling a set of double trailers, operated by William Frakes (49) of Nampa, ID was westbound when it left the roadway and overturned. Frakes sustained fatal injuries and was pronounced deceased.

Hwy. 97 Fatal, Deschutes Co.

On Thursday, September 2, 2021 at approximately 1:05 AM, Oregon State Police Troopers and emergency personnel responded to a two vehicle crash on Hwy 97 at Vandervert Road. Preliminary investigation revealed a westbound Dodge Caravan, operated by Sherri Wood (46) of Lyons failed to stop when entering Hwy 97 from Vandervert Road. The Dodge Caravan struck the drivers side a northbound commercial motor vehicle operated by Abelardo Eleneshiguera (54) of Bakersfield, CA. The commercial motor vehicle caught fire and was fully engulfed and burned beyond recognition. A passenger in the Dodge Caravan, Robert Owens (56) of Seaside was pronounced deceased. Wood was transported via air ambulance to St. Charles with life threatening injuries. Eleneshiguera escaped the burning CMV and was uninjured.

I-84 Fatal, Baker Co.

On Monday, September 6, 2021 at approximately 6:40 PM, Oregon State Troopers and emergency personnel responded to a commercial motor vehicle crash on Interstate 84 near milepost 338. Preliminary investigation revealed a white Freightliner CMV, operated by Hassen Ibrahim (38) of Dublin, OH, was westbound when a set of dual tires detached from the flatbed trailer in tow. The dual tires bounced across the center concrete barrier and became airborne to a great height. The tires came down into the windshield and cab of an eastbound blue Freightliner CMV, operated by James Green (50) of Caldwell, ID. Ibrahim stopped, chained up the broken axle and left the scene. He was located by Troopers near Baker City. Green sustained fatal injuries and was pronounced deceased. Ibrahim was not injured. A passenger in Ibrahim's CMV, Mohamed Kulale (61), was also uninjured. OSP was assisted by Baker County Sheriff's Office, Huntington Fire Rescue and ODOT. Interstate 84 was closed for approximately 6 hours. **Investigating Troopers are requesting assistance-Any witnesses to the crash that were not in-

terviewed are requested to contact *OSP and reference SP21-256040. Additionally, witnesses reported a male in a white CMV stopped and spoke with Ibrahim. Troopers would like to identify this subject and obtain a statement. **

Hwy. 207 Fatal, Morrow Co.

On Sunday, September 12, 2021 at approximately 12:16 PM, Oregon State Police Troopers and emergency personnel responded to a motorcycle crash on Hwy 207 near milepost 20C, south of Heppner. Preliminary investigation revealed a Suzuki motorcycle, operated by Edmund LaPlante (70) of Oregon City, was southbound when it failed to negotiate a curve and left the roadway. LaPlante sustained fatal injuries and was pronounced deceased.

Fatal I-5, Marion Co.

On Friday, September 10, 2021 at approximately 12:18 AM, Oregon State Police Troopers and emergency personnel responded to a two-vehicle crash on southbound Interstate 5 near milepost 264. Preliminary investigation revealed a Toyota Prius, operated by Julie Lafayette (57) of Gervais, was northbound in the southbound lanes and struck an Infiniti, operated by Mohamed Mustafa (24) of Wilsonville. Lafayette sustained fatal injuries and was pronounced deceased. Mustafa was transported to a local hospital with critical injuries. Interstate 5 was closed for approximately 3.5 hours.

Hwy. 6 Fatal, Washington Co.

On Sunday, September 12, 2021 at approximately 5:15 PM, Oregon State Troopers and emergency personnel responded to a single vehicle crash on Highway 6 near milepost 33. Preliminary investigation revealed a Ford F150, operated by Gene Carlson (66) of Oregon City, was towing a 17-foot boat eastbound on Hwy 6. For unknown reason the Ford drifted off the highway and lost control, striking a guardrail and rolling. Carlson sustained fatal injuries and was pronounced deceased. Hwy 6 was closed for approximately 2 hours.

Hwy. 7 Fatal, Baker Co.

On Monday, September 14, 2021 at approximately 3:50 PM, Oregon State Troopers and emergency personnel responded to a single vehicle crash on Hwy 7 near milepost 23. Preliminary investigation revealed that a KTM 950, operated by Lawrence Drake (78) of Ashland, was southbound on Hwy 7 when it failed to negotiate a curve and left the roadway before crashing. Drake sustained fatal injuries and was pronounced deceased.

I-84 Fatal, Umatilla Co.

On Thursday, September 16, 2021 at approximately 8:15 pm, Oregon State

Police Troopers and emergency personnel responded to a two-vehicle crash on Interstate 84 near milepost 193. Preliminary investigation revealed a Volkswagen Jetta, operated by Jate Frost (20) of Randlett, UT, was traveling eastbound when it rear-ended a commercial motor vehicle, operated by Ediberto Ramirez Carrillo (31) of Hermiston. Frost sustained serious injuries and was flown via Life Flight to Kadlec Medical Center in Richland, WA. The right front passenger in the Jetta, Richard Schleicher (24) of Stockton, OK, sustained fatal injuries and was pronounced deceased. The rear seat passenger in the Jetta, Jesse Hopper (21) of Magnum, OK sustained serious injuries and was transported to OHSU in Portland. Ramirez Carrillo was not injured. All three occupants of the Jetta were contestants at the Pendleton Roundup. The CMV was fully loaded with potatoes.

Hwy. 164 Fatal, Marion Co.

On Monday, September 20, 2021 at approximately 11:28 AM, Oregon State Police Troopers and emergency personnel responded to a single motor vehicle

crash on Hwy 164 near milepost 1. Preliminary investigation revealed a Nissan Frontier, operated by Michelle Duclos (58) of Jefferson, was northbound when it left the roadway and struck a cement bridge abutment. Duclos sustained fatal injuries and was pronounced deceased. Hwy 164 was closed for approximately 3.5 hours.

Hwy. 20 Fatal, Malheur Co.

On Sunday, August 1, 2021 at approximately 2:39 A.M., Oregon State Police Troopers and emergency personnel responded to a single vehicle crash on Highway 20 near milepost 244. Preliminary investigation revealed a Suzuki Grand Vitara, operated by Monique Alires (22) of Ontario, was eastbound when it lost control and rolled multiple times. Alires was transported to the hospital with injuries. Passenger, Lewis Whipple Jr. (23) of Ontario, sustained fatal injuries and was pronounced deceased.

Fatal Hwy. 97, Jefferson Co.

Troopers and emergency personnel responded to a two vehicle crash on Hwy 97 near mile post 104. Preliminary investigation revealed a Chevrolet Impala, operated by Charles Carroll (51) of Madras, was northbound when it left the roadway, lost control, and entered the southbound lane colliding with a Mazda CX-5 operated by Greg Rockwell (70) of Bothell, WA.

Carroll was transported by air ambulance to the hospital. Passenger in the Chevrolet, Donna Reynaga (52) of Ontario, CA. sustained fatal injuries and was pronounced deceased. Rockwell and passenger, Colleen Donahue (62) of Bothell, WA. were both transported to the hospital with injuries.

Fatal Hwy. 99E, Marion Co.

On Thursday, July 29, 2021 at approximately 10:43 P.M., Oregon State Police Troopers and emergency personnel responded to a two vehicle collision on Hwy 99E at Boones Ferry Rd. Preliminary investigation revealed a Hyundai Santa Fe, operated by Jose Sandoval Flores (40) of Woodburn, was northbound on Hwy 99E and turned left, onto Boones Ferry Rd, into the path of a southbound Harley Davidson motorcycle operated by Jerald Stewart (64) of Salem. Stewart sustained fatal injuries and was pronounced deceased. Flores was not injured.

Missing Kayaker Found Deceased

LCSO update: On Friday July 30th, 2021 shortly after 10:00am the Lane

County Sheriff's Office along with local fire authorities were advised that a citizen located a deceased person in the water of Fall Creek Reservoir. Sheriff's Office personnel responded and confirmed the body to be that of missing kayaker, Glenn Hornsby. Hornsby, a 53 year old Eugene resident, was reported missing on Monday July 30th. His kayak and vehicle were in the Fall Creek area that same night. The Lane County Sheriff's Office is working with the Lane County Medical Examiner's Office to determine a cause of death. At this time there are no indications of foul play.

Suspect Arrested in Vandalism Incident

LCSO release - Acting on leads developed during the investigation of the vandalism that occurred at a residence in the Santa Clara area on July 16th 2021, deputies were able to establish probable cause to apply for a search warrant to search another residence in the Santa Clara area. On Sunday, August 1st 2021, deputies executed this warrant and contacted at least one male believed to be involved in the July 16th incident. Subsequent to investigation deputies arrested 19 year old Maxwell Adam Lewis and lodged him at the Lane County Jail. Several items of evidence related to the vandalism incident were uncovered including a paintball gun and the suspect vehicle depicted in the surveillance images. The Lane County Sheriff's Office would like to thank the public for its assistance in this case. At this time the suspect vehicle that had previ-

ously been depicted is no longer of interest.

Fatal Hwy. 97, Wasco Co.

On Tuesday, August 3, 2021, at 8:45 A.M., OSP Troopers responded to a two-vehicle crash on Hwy-97 at milepost 73. A Commercial Motor Vehicle (CMV), operated by Ronald Sims (25) of Redmond, was northbound when a silver Dodge Pickup, operated by William Robinson (74) of Wasilla, Alaska, crossed into the northbound lanes for an unknown reason. The two vehicles hit head-on. Both individuals sustained fatal injuries. Highway 97 was closed for approximately 5 hours.

Fatal Hwy. 58, Lane Co.

On August 3, 2021, at approximately 3:00 P.M., OSP Troopers from the Oakridge Outpost, La Pine, and Bend Offices responded to the report of a head-on collision on Hwy 58 near milepost 61. Preliminary investigation revealed that a Nissan Sentra, driven by Jerry Edward Anderson (61) of Gilchrist, was westbound when he failed to negotiate a corner. The Sentra crossed the eastbound lanes and impacted a guardrail. It then went into the eastbound lane and collided head-on with a Commercial Motor, driven by Thomas Michael Jennings (45) of Eugene. Anderson sustained fatal injuries and was pronounced deceased. Jennings was uninjured.

Teenagers caught driving 95 mph get \$8,000 in fines for poaching wildlife

Oregon Department of Fish and Wildlife, Stop Poaching Campaign- ODFW release - SALEM, Ore. — An Oregon

couple who poached two mule deer bucks, a pronghorn and three Canada geese will pay more than \$8,000 in court fees and restitution. An Oregon State Police Fish and Wildlife trooper discovered the crimes following a traffic stop last year. In October of 2020, Trooper James Hayes stopped Justin Borchert, 19, of Bend for traveling 95 mph in a 65 mph zone near La Pine. During the stop, Hayes noticed Borchert's jacket had blood on it. There was also blood on the bed of the pickup. Hayes asked about the blood, and Borchert explained that his passenger in the truck, Tyra Stevens, had shot a deer a few days earlier near Blue River. Stevens, 19, also of Bend, confirmed the story, saying she had used her western Oregon deer tag. Neither Borchert nor Stevens realized the Blue River area had burned up and was closed after the Holiday Farm wildfire. After further questioning, Borchert and Stevens admitted to taking two buck mule deer out of season. Additional investigative work by the OSP Fish and Wildlife division revealed the two had also poached a pronghorn and three Canada geese. On May 25, 2021, Lake County Judge David Vandenburg convicted Borchert and Stevens of one count each of illegal take of wildlife. Borchert must pay fines and restitution in the amount of \$7,500 to the Oregon Department of

Fish and Wildlife (ODFW). Stevens must pay \$1,000 to ODFW, along with \$202 in court fees. Each lost their hunting privileges for three years, remain under bench warrant for one year, and must serve 40 hours of community service. ODFW Wildlife Division Administrator, Bernadette Graham Hudson, is frustrated by ongoing poaching throughout the state. "Poachers remove opportunities for true sportsmen and women who purchase licenses and tags, and follow the rules," she said. "Hunters may wait years for the opportunity to legally take a mule deer or pronghorn."

Stolen Vehicle Arrest

Death Investigation Lane Co.

LCSO release - On 08/09/21 at approximately 6:34am the Lane County Sheriff's Office received a report that someone had been shot at a residence on Hwy. 58 near Hilltop Dr. Deputies and OSP Troopers responded and located a male with an injury to his head consistent with a gunshot wound. He was conscious and transported to an area hospital. This male advised that his handgun was missing from the residence. Also in the home was a female that had what appeared to be a gunshot wound to the chest. She was pronounced deceased. While investigating the scene, deputies spotted a male armed with a handgun hiding in the bushes next to the driveway. After approximately 45 minutes he surrendered and was taken into custody. A handgun was found in his possession.

The status of the male that had been transported to the hospital remains unknown. A small child, related to the victims, was also in the residence when the incident occurred. Meyers and Hartwell had been reported missing when they did not return home on August 14, 2021.



office has requested Oregon State Police to lead the investigation into the officer involved shooting and the pedestrian fatality. No further information is available for release at this time and names will be released when appropriate.

Illegal Marijuana Grow, Klamath Co.

On August 3, 2021, Oregon State Police Detectives served a search warrant at an illegal marijuana grow on Harpold Road, Malin, Oregon. Information was developed that there was potentially an illegal marijuana grow at a 150-acre property on Harpold Road. Detectives investigated further and discovered over 85 – 30 foot by 100-foot greenhouses on the property that appeared to be growing illegal marijuana. As part of the investigation, detectives determined that there were no permits obtained to legally grow hemp or marijuana on the property, for any purpose. Additionally, as the investigation continued, detectives learned there was potentially theft of water and

unlawful use of groundwater occurring as part of the illegal marijuana grow. Marijuana is a very water-intensive plant and since illegal grows don't receive water permits, these grows deplete water at even more wasteful rates with no regard for sustainability. When the search warrant was served, detectives discovered over 22,000 illegal marijuana plants on the property. Preliminary tests confirmed the plants were marijuana and not hemp. Additionally, evidence was discovered to support the Unlawful Use or Appropriation of Ground Water. Detectives conducted multiple interviews and seized evidence from the property. Additional follow up investigation is being conducted; however, the following charges on the property owners are going to be referred to the Klamath County District Attorney's Office: ORS 475B.337 Unlawful Possession of Marijuana/Hemp; ORS 475B.349 Unlawful Manufacture of Marijuana; ORS 475B.227 Conspiracy to Export Marijuana Items; ORS 537.535 Unlawful Use

or Appropriation of Ground Water.

Pot Bust Union Co.

The Oregon State Police and the Union County Sheriff's Office conducted an investigation into illegal marijuana grow located at two separate properties in Union, Oregon. Investigators were able to develop probable cause the marijuana being grown, was in fact not licensed making it illegal. The Oregon State Police applied for and were granted a search warrant for the two properties identified during the investigation. Armed Standoff in Lane Co.

At approximately 10:54am, 31 year old Austin Kane Waszkiewicz, surrendered to deputies after six hours of negotiation. Waszkiewicz is reported to have struck a family member in the head with a firearm in Coburg just prior to the stand-off. Shortly after the assault authorities were able to make phone contact with Waszkiewicz and determine his location. Waszkiewicz was observed with a blue Chevrolet pickup stopped in a gravel pull-out at the intersection of Diamond Hill Rd. and Powerline Rd. in Harrisburg, armed with a firearm. Waszkiewicz refused to surrender and made statements that he intended to provoke deputies into an armed confrontation. Utilizing armored rescue vehicles acquired at no cost from the Federal 1033 program, deputies were able to safely contain the scene and keep Waszkiewicz from harming anyone else. The use of these armored rescue vehicles allowed deputies much needed time to negotiate with Waszkiewicz and de-escalate the situation. Negotiators from the Lane County Sheriff's Office Crisis Negotiation Team (CNT) were crucial in de-escalating Waszkiewicz and convincing him to peacefully surrender. The Negotiations Operations Center (aka 'NOC') is a specialized vehicle outfitted with state of the art communications and surveillance equipment. This vehicle was recently acquired by the sheriff's office utilizing funds from the Department of Homeland Security grant along with a Department of Justice grant. After a long, intense stand-off, Waszkiewicz eventually agreed to surrender and physical force was not used to enact his arrest. A firearm and multiple knives were recovered from within his vehicle. Waszkiewicz was transported to the Lane County Jail and lodged on charges including Assault II - APA, Menacing - APA, Interfering



Small Plane Crash near Eugene

A small Cessna aircraft has crashed into a field near Green Hill Road and Meadowview Road near the Eugene Airport. One person has been transported to a hospital for medical treatment. The identification of the person, as well as the extent of injury, is not available at this time. Community members are asked to avoid the area to allow emergency responders to work. Lane County Sheriff's Office is coordinating with federal officials, including the Federal Aviation Administration (FAA), to conduct an investigation. Lane Co. Pursuit

The Tacoma was speeding through red traffic lights and swerving all over the road as it drove in and out of traffic for an unknown reason. The deputy attempted to initiate a traffic stop, but the driver fled and initiated a pursuit that led eastbound on I-105 towards I-5. The Tacoma continued to drive in a similar manner and reached speeds of 100 MPH. At one point, the Tacoma crashed into another vehicle, occupied by a mother and baby, then continued westbound on Beltline Highway (The mother and baby were thankfully uninjured) Numerous attempts were made to spike strip the Tacoma's tires, but were unsuccessful. The pursuit continued to West 11th in Eugene then ended off Royal Avenue shortly after the driver lost control of the Tacoma and hit a traffic sign. The driver exited the vehicle then challenged deputies and officers to kill him. The driver failed to obey police commands and reached at his waist and into his pockets multiple times. A police K9 was deployed and the driver was taken into custody without further incident. The driver was identified as 21 year old Jesse Bravo. Bravo sustained minimal injury and was transported to the hospital for evaluation. Bravo was later lodged at the Lane County Jail for Attempting to Elude a Police Officer, Failing to Perform the Duties of a Driver (x2) Driving Under the Influence of Intoxicants, Unlawful Delivery of a Controlled Sub-



Shots Fired in Eugene

It was reported by family members that Wilkinson was making delusional comments, shot the dog, and then barricaded himself in a bedroom when confronted by family. He was taken into custody at 1:34 pm and lodged at the Lane County Jail for the crimes of Unlawful Use of a Weapon and Animal Abuse-1. There is no ongoing threat to the public at this time.

Former Weyco Accountant Sentenced

EUGENE, Ore.—Susan Tranberg, 62, of Eugene, Oregon, was sentenced to federal prison today for defrauding her former employer, the Weyerhaeuser Company, out of more than \$4.5 million, announced Acting U.S. Attorney Scott Erik Asphaug. Tranberg was sentenced to 57 months in federal prison and three years' supervised release. According to court documents, beginning as early as June 2004 and continuing to January 2019, Tranberg defrauded Weyerhaeuser out of more than \$4.5 million by submitting fraudulent invoices for payment to a fake vendor she created. Tranberg had worked for Weyerhaeuser in Springfield, Oregon in various positions for more than 40 years. A financial analysis determined that the vast majority of the money was used to fund a lavish lifestyle of expensive dinners, vacations, six-figure wedding expenses, and shopping sprees. At some point in or before June 2004, Tranberg created a fake timber contract between the company and a vendor she named after her mother, who was un-

ware of the scheme. Over the next 10 years, Tranberg would use her positions in the company's accounting and finance departments to request cashier's checks, which she then cashed into her own bank account. During this time period, Tranberg requested and received more than \$2.6 million. In June 2014, Weyerhaeuser transitioned to a new payment processing system. To continue her scheme, Tranberg set up a fake vendor account in the new system and attached a letter purportedly from her mother describing the documentation provided to set up the account. This documentation included a Form SSA-1099 Social Security Statement and a forged Form W-9 Request for Taxpayer Identification Number and Certification. At the time Tranberg sent the letter and documentation, Tranberg's mother had been deceased for five years. After setting up the fake vendor account, Tranberg continued her scheme by forging colleagues' signatures on check requests and using her colleagues' computer login credentials without authorization to create requests and approve fraudulent payments. All requested cashier's checks were sent via private or commercial interstate carrier directly to Tranberg. During these final five years, ending in January 2019, Tranberg requested and received nearly \$1.9 million. On January 29, 2020, Tranberg was charged by superseding criminal information with mail fraud, aggravated identity theft, and tax evasion. On January 30, 2020, she waived indictment and pleaded guilty to all three charges. During sentencing, U.S. District Court Judge Michael J. McShane also ordered Tranberg to pay more than \$5.3 million in restitution, to include \$775,984 to Weyerhaeuser, \$3,805,223 to the Crime Victims Fund, and \$807,033 to the IRS.

Firearms, Illegal Drugs Seized west of Eugene

On 04-01-2021, the Lane County Sheriff's Office responded to an address in the 27000 block of Lawrence Rd. north west of Elmira regarding the location of a stolen vehicle. During the investigation deputies encountered what appeared to be a large, illegal Butane Marijuana Hash Oil (BHO) extraction lab. The Sheriff's Office applied for and was granted a search warrant for the Lawrence Rd. property and an associated address on E. Broadway Ave. in Veneta. Several people were contacted on the property and identified. During the warrant service deputies additionally discovered a vacant residence at the Lawrence Rd. property that was being solely used for growing suspected psilo-

cybin mushrooms, commonly known as "magic mushrooms" due to their hallucinogenic effect on people. The entire residence had been converted into a growing and drying structure for the mushrooms. The residence was filled with racks from floor to almost ceiling height that held what is estimated to be hundreds of clear, grocery sized bags containing an unknown soil type material and multiple growing mushrooms. The warrant at both locations was served without incident. The manufacture of Butane Marijuana Hash Oil is extremely dangerous due to the explosive, highly flammable nature of butane as used in the extraction process. Butane Marijuana Hash Oil extraction labs are illegal by Oregon Revised Statute unless the manufacturer is licensed and in compliance with state statutes through the Oregon Liquor Control Commission (OLCC). This location was not a licensed site. The Sheriff's Office was assisted by the Oregon State Police and Federal Drug Enforcement Agency (DEA) during the investigation. Notable items seized during the execution of the warrant: 16 Firearms, one of which was reported stolen; A large amount of US

currency packaged in bundles of \$10,000; A cash counting machine; Apprx. 465 bags of suspected psilocybin mushrooms; Conservatively estimated at dozens of pounds of finished marijuana hash oil extract; Conservatively estimated at hundreds of pounds of dried marijuana; An enclosed cargo trailer; A recovered stolen pickup; No suspects have been taken into custody at this time and the investigation is on going.

Reward of \$6500 raised by Oregon hunters for information on three elk poached near Bend

ODFW release - BEND, Ore. — The Oregon Hunters Association has bolstered the reward up to \$6500 for information that leads to an arrest or citation in the case of three elk that were poached west of Bend on or about Oct. 28, 2020. The bull, cow and spike elk were discovered separately, but all three were in the same area and appear to have been killed at the same time. The cow and spike were left to waste in a blatant demonstration of a thrill-kill. The large bull had its head and shoulders removed as a trophy. OHA Bend, Redmond, Capitol, Josephine and Mid-Columbia chapters, along with several private donors, pooled resources to increase the reward amount. The Bend chapter hosted an online auction which raised \$2,150. Fundraising efforts raised awareness about the case, according to Greg Petsch, who is the banquet chair and led the effort. “There is so much poaching,” Petsch said, “They did this for their own satisfaction. I don’t know how they find this satisfying.” OSP Fish and Wildlife Troopers discovered the first carcass, a cow elk, on Oct. 30 after a call to the Turn In Poachers (TIP) Line from a hunter who came across the carcass while scouting the Dry Canyon area East of Sisters near Hwy 126 and Quail Tree Drive. Troopers investigating the area around the cow subsequently discovered a large bull elk carcass. Although bull elk were in season at the time, the poacher had taken only the head, antlers and some shoulder meat. It is a crime to leave carcasses to waste even if it is legal to kill the animal. Two days later, on Nov. 1, another call came through on the TIP Line from a hunter who reported finding a spike elk carcass. A spike elk is a one-year-old male. Troopers located the spike elk about 40 yards from where the cow had been. Based on decomposition, all three animals were shot at or near the same time, and certainly the same day according to OSP F&W Senior Trooper Creed Cummings, who processed the scene. “Sometimes people are reckless in shooting and they get the wrong species or gender. We were hoping that at least the cow (meat) would be salvageable, but it wasn’t,” Trooper Cummings said, “It’s disappointing that they were just left. And it adds another charge to the initial crime.” Petsch is quick to declare the differences between hunters and poachers. “Hunting is about being outdoors with friends and your family, not necessarily harvesting something,” he said, “That is the experience.

It’s the camaraderie.” Oregon’s Stop Poaching campaign coordinator Yvonne Shaw agrees. “This is a blatant waste of Oregonians’ natural resources,” she said, “Not only have these animals been removed from legal hunting in season, they are also removed from chance encounters with hikers, photographers and others who appreciate the opportunity to experience wildlife. Poachers take from all of us.” All three elk were most likely shot on opening day of the East Central Cascade elk season which ran Oct. 28 through Nov. 1, 2020. Instead of the cash reward, a caller to the TIP Line could opt for 6 hunter preference points if their report leads to a citation. OSP Troopers would like anyone in the area who heard shots at night or noticed anything unusual on opening day of the season to call the TIP Line at 1-800-452-7888 or by cell *OSP (*677) or by email TIP@osp.oregon.gov.

Tundra Swans

OSP release - The Oregon State Police Fish & Wildlife Division is asking for the public’s help to identify the person(s) responsible for the unlawful taking of two Tundra Swans in Harney County. On April 1, 2021 a U.S. Fish and Wildlife Service Officer discovered two deceased Tundra Swans off of Embree Bridge Road near Oil Well Road in the East Fork of the Silvies River. The U.S. F&W Officer notified the Oregon State Police Fish and Wildlife Division which are now assisting in the investigation. The U.S. F&W Officer determined the Tundra Swans had been shot with a small caliber bullet sometime between March 31 and April 1. Poaching wildlife and damaging habitats affects present and future generations of wildlife, impacts communities and the economy, and creates enforcement challenges.

I-5 Fatal, Marion Co.

Preliminary investigation revealed that a Mazda M23, operated by Cassidy Schmidt (19) of Albany, was southbound when it struck a pedestrian in the roadway. It is unknown at this time why the pedestrian was in the roadway. The pedestrian sustained fatal injuries and was pronounced deceased. His name will be released when appropriate.

On Monday, April 12, 2021 at approximately 6:50 P.M., Oregon State Police Troopers and emergency personnel responded to a two vehicle crash on Highway 199 near mile post 25. Preliminary investigation revealed that a Dodge Du-

rango, operated by Billy Thornhill (60) of Kerby, was entering Hwy 199 from a driveway and pulled in front of a Freightliner dump truck (towing a 33’ flatbed trailer), operated by Mark Tripp (51) of Grants Pass, was unable to stop and collided with the Durango. Thornhill sustained fatal injuries and was pronounced deceased. Tripp was not injured.

Lockdown at McKenzie School

OSP report - On the morning of 04.16.2021 Oregon State Police (OSP) and Lane County Sheriff’s Office (LCSO) were dispatched to the McKenzie High School regarding the location of a stolen vehicle. The involved 2020 GMC Traverse had been reported stolen out of Albany, Oregon. An OSP Trooper arrived and began investigating. School staff reviewed security footage and noticed the adult male associated with the stolen vehicle had earlier entered the main hallway of the school. The current location of the male was unknown as were the male’s reason for entering the school. Staff placed the school on lockdown and additional OSP Troopers and LCSO Deputies responded to McKenzie High School. Further reviewing of security footage showed the suspect walking outside on school property. An OSP Trooper located the suspect about a mile away from the school and took him into custody without incident. The suspect was identified as 33 year old Joshua Walker-Graham of Portland, Oregon. The school lifted the lockdown once Walker-Graham was taken into custody and there is no ongoing threat to the school or area residents. Pleads Guilty to Distributing Meth in Oregon

PORTLAND, Ore.—A Coachella, California man pleaded guilty today to transporting five pounds of methamphetamine from Coachella to Aumsville, Oregon, announced Acting U.S. Attorney Scott Erik Asphaug. Gerardo Figueroa-Felix, 36, pleaded guilty to one count of distribution of methamphetamine. According to court documents, on January 7, 2019, Marion County Sheriff's Office deputies responded to a call that squatters had returned to a foreclosed property in Aumsville and that there was methamphetamine inside the house. Deputies had locked the property four days prior in response to a court order. Two deputies approached the house together and spotted a white Chevrolet pickup truck with a California license plate backed into the driveway. As they approached, the deputies saw Figueroa-Felix tying up a tarp near the back of the vehicle. One of the deputies approached Figueroa-Felix and asked why he was on the property. Figueroa-Felix produced three identification cards with his name and photograph on them. The deputy watched as Figueroa-Felix began to reach his hands into the front pockets of his jacket and ordered him to remove them. The deputy then proceeded to search Figueroa-Felix's person and located a loaded semi-automatic Ruger 9mm handgun in his left-front pants pocket. The deputy discovered a second

loaded handgun tucked into Figueroa-Felix's waistband. Figueroa-Felix also had a double magazine pouch attached to his belt. The investigation revealed Figueroa-Felix was a drug mule from Coachella and was paid to transport five pounds of crystal methamphetamine from Southern California to Oregon. He previously sold two pounds of methamphetamine on the Aumsville property and returned that day to sell more. Deputies seized three pounds of methamphetamine and large quantities of live .45 caliber ammunition from his truck along with another handgun. On March 20, 2019, a federal grand jury in Portland returned a three-count indictment charging Figueroa-Felix with possession with intent to distribute methamphetamine, distribution of methamphetamine, and possession of a firearm in furtherance of a drug trafficking crime. Figueroa-Felix faces a maximum sentence of 40 years in prison, a \$5 million fine, and four years of supervised release. With Figueroa-Felix's continued acceptance of responsibility, the government has agreed to a recommended sentence of 70 months in prison and four years' supervised release. Figueroa-Felix will be sentenced on **June 7, 2021** before U.S. District Court Judge Karin Immergut. This case was investigated by the Marion County Sheriff's Office, Salem Police Department, and the Bureau of Alcohol, Tobacco, Firearms, and Explosives (ATF). It is being prosecuted by Hannah Horsley and Pamela Paaso, Assistant U.S. Attorneys for the District of Oregon.

Manufacturing Destructive Devices

On March 18, 2021 the Oregon State Police Explosives Unit in conjunction with the Medford Police Department served a search warrant on a residence in the 1100 block of Char Way, in Medford, Oregon. This was the result of an ongoing investigation related to multiple reports of explosions across the Rogue Valley. Investigators from the Oregon State Police and the Medford Police Department identified a suspect and during the search of the residence located numerous items relating to the manufacturing of destructive devices. Brian Lighthill (23) was arrested and lodged in the Jackson County Jail. Lighthill was charged with 23 counts of Manufacturing of a Destructive Device and 9 counts of Possession of a Destructive Device.

Multiple Explosive Devices in Southern Oregon

On March 18, 2021 the Oregon State Police Explosives Unit in conjunction with the Medford Police Department served a search warrant on a residence in the 1100 block of Char Way, in Medford, Oregon. This was the result of an

ongoing investigation related to multiple reports of explosions across the Rogue Valley. Investigators from the Oregon State Police and the Medford Police Department identified a suspect and during the search of the residence located numerous items relating to the manufacturing of destructive devices. Brian Lighthill (23) was arrested and lodged in the Jackson County Jail. Lighthill was charged with 23 counts of Manufacturing of a Destructive Device and 9 counts of Possession of a Destructive Device. These devices started being reported February in Medford, Central Point and White City and were being thrown from a car. Oregon State Police and Lane County Deputies were dispatched to the call. About 15 minutes later the first arriving Trooper located Travis William Crum standing in the middle of Highway 36 and he was subsequently taken into custody without incident. Shooting Investigation Elmira

On March 25, 2021, starting at about 3:30 AM, the Lane County Sheriff's Office began receiving 911 calls from residents in the 24000 block of Horn Road in Elmira. Callers reported hearing loud yelling and shots being fired. A few minutes later, one of the female callers reported that a neighbor, identified as 34-year-old Elmira resident Brandon Coats, was outside her residence trying to force his way inside. The female caller, her husband and their minor child were home at the time. The female's husband armed himself with a handgun in order to protect his family and a few moments later Coats forcibly broke open their front door armed with a shotgun. Coats was shot by the caller's husband during the confrontation and held at gunpoint until Sheriff's Deputies could arrive. Upon the deputies' arrival,

Coats was transported via ambulance to a local hospital, where he is being treated for what appear to be non-life threatening wounds. The victims in the incident were physically uninjured and are cooperating with the investigation. The investigation to this point indicates that Coats, for a yet-to-be determined reason, fired several rounds from at least two firearms inside his residence and then went over to at least two neighboring residences demanding to be let inside. The second neighboring residence is where Coats is alleged to have forcibly broken open the front door armed with a shotgun, resulting in the male homeowner shooting him. At this stage of the investigation, Coats is being held for Burglary 1, Menacing X3, Unlawful Use of a Weapon and Criminal Mischief. Additional charges could result as the investigation continues.


